On Second Thought...

You may have noticed something new on the front of the bulletin the last few months. It's our new Vision Statement that was recently adopted by the Session. In a process that began in the spring of 2017, the elders worked with the data collected at the Fireside Chats, identifying the recurring themes they found there. They answered the question, "If you had to describe Second Presbyterian Church in just one word, what would it be?" They did Bible studies on why the church exists, completing the sentence, "The Church exists to...".

At the retreat in August they took all of this information and divided into 3 teams, each tasked with writing a Vision Statement for the congregation. After critiquing, combining, rewriting, and refining these statements, a preliminary Vision Statement was written. The elders then took a month to pray over that statement and came to the September Session meeting with their final suggestions. Once edited and revised, the Vision Statement was adopted.

Responding in gratitude to God's love and grace, we are a welcoming, faithful, and hopeful community, following Jesus and serving him in the world.

This is our Vision for who we want to be and what we want to be about. It is a statement that says who we are, as well as who we are becoming. We are never fully what the statement says, and yet we are always engaged fully in living into this vision.

As we begin our Bicentennial celebration this year, it is important to note that this Vision Statement doesn't speak for how things have always been. It may not even be our Vision five years from now when we revisit it. But for now, this is who we are and who we want to be. Welcoming. Faithful. Hopeful. Following. Serving. All in response to what God has done in us and for us.

I urge you to memorize this statement. Let it guide you in the new year. If you are the kind of person who likes to make New Year's Resolutions, resolve to be these things in and for the world.
Let's commit to living out this vision together, as a community, in and for the world.
Let's strive in every committee meeting, Bible study, Sunday School class, and fellowship group to ask ourselves, "How are we

doing with our vision? What have we done since our last meeting to make our vision a reality? What can we do between now and our next meeting to be 'a welcoming, faithful, and hopeful community, following Jesus and serving him in the world."

This year there will be several changes in our life together. None of these changes are being made erroneously, carelessly, or just for the sake of change. All of them are being made with the Vision Statement in mind, with our desire to follow Jesus faithfully and to serve him in the world. In fact, everything we do in the coming year should be done with this Vision in mind, in gratitude for God's love and grace, and in our desire to "glorify God and enjoy God forever."

May we have a wonderful year of celebrating and responding to God's love and grace working in this congregation for the last 200 years! May we be truly welcoming, not just of one another, but of new people and new ideas. May we do it with the faithfulness and hopefulness that have characterized this congregation for two centuries. May we recognize what a privilege it is to follow Jesus and serve him in the world, and in so doing abandon our own agendas for his.

New Sunday Morning Security Measures

In light of the recent attacks on houses of worship in our country, the Facilities Team has been discussing for several months now what, if any, security measures to adopt on Sunday mornings to both ensure the safety of our worshiping congregation and make sure that anyone who wants to join our congregation for worship is free to do so. We do not want to act out of a sense of fear, but we do want to be responsible in protecting our congregation.

In October we showed a video at a Wednesday night dinner entitled *Run*, *Hide*, *Fight*. This is a video recommended by most law enforcement agencies that details what to do in the event of an active shooter event. If you were not present for that you can find this video easily on the internet. If there is an active shooter event, we encourage everyone to exit the building, if possible, and move towards the Forensic Center next door.

In addition to discussions amongst ourselves, we have also had representatives attend workshops provided by both the Knox County Sheriff's office and the Presbytery of East Tennessee. As a result, we have adopted the following policy for Sunday mornings.

At 11:05 a.m., the custodian will begin locking all of the exterior doors to the building, with the exception of the main sanctuary doors. If you arrive after 11:05 and want to enter the building through any door other than the main sanctuary doors, the following doors will be monitored and entry can be obtained by ringing the bell next to the door: atrium door, porte-cochere door, and breezeway door


between the main building and the children's wing. A person in the church office will have access to the security cameras and intercom system and will be able to remotely allow entry to anyone arriving after 11:05 a.m.

The main sanctuary doors will remain unlocked and open throughout the entire worship hour. Ushers will remain in the narthex throughout worship to welcome anyone who comes in late and assess if a threat is present. The person monitoring the cameras will also assist in threat assessment. A communication system will be installed between the church office and the sanctuary so that if there is a threat in either place, the other will be able to call 911 for emergency assistance. Finally, in every worship service a member of the Facilities Team will be on the back pew near the main entry doors to the sanctuary and will have a can of pepper spray to disable anyone that enters the sanctuary and is deemed to be threatening those in worship.

Obviously, there is no way to plan or prepare for every contingency. We feel, however, that this policy makes sense and goes a long way to ensuring the safety of our congregation, in the event of an attack of some kind. Be assured that we are continuing to discuss our response to such situations and will address any other needs that may arise. Please remember, if you arrive after 11:05 a.m., enter through the main sanctuary doors or ring the bell at one of the other doors and someone will let you in.

inspiring and uplifting worship service each Sunday and that God would be glorified in and through our worship. Their dedication and humility have been gifts to this congregation.



DAVID STULTZ INTERIM ORGANIST

David Stultz is an 19-year-old freshman at the University of Tennessee in Knoxville and he graduated from Baylor School in Chattanooga TN. He has studied piano with Dr. Sigrid Luther for the past fourteen years.

For three years, David studied organ with Jason DuRoy, organist at Signal Mountain Presbyterian Church. In piano, David has received superior ratings and scholarships from the Chattanooga Music Teachers Association. In 2015, he won first prize and the hymn-playing award in the Young Organist Competition sponsored by the Greater Columbia AGO Chapter. He has performed with the Jericho Brass and twice with the Chattanooga Youth Symphony Orchestra; one performance included the Saint-Saëns "Organ Symphony."

He enjoyed playing every Monday for Baylor School Chapels, local weddings, and memorial services along with subbing for organists at various churches in the area. David was the official organ substitute for Judy Glass at First Presbyterian Church of Chattanooga, and he served as organist for two years at Lookout Mountain Presbyterian Church.

As a winner of the 2015 organ competition, David returned to Columbia to perform a full-length concert at Trinity Episcopal Cathedral. In January, he placed 2nd in the Winston-Salem School of the Arts National High School Organ Competition. He also studied organ with Dr. Sarah Harr who is the organist at First Lutheran Church of Chattanooga.

David is currently majoring in organ performance and studying under Dr. Edie Johnson.

Wesley's Covenant Prayer

On December 31st we are going to have a brief Covenant Renewal service based on John Wesley's service of the same name. Wesley was looking for a way to mark the renewal of a believer's covenant with God when he found, in the Reformed Tradition, a service rededicating oneself to God for the new year. He adapted it for his own use and the service he designed is still in use today.

Though Wesley did not use it at any particular time of the year, a tradition developed in British Methodism of using the service near the beginning of the new year. The centerpiece of the service is the following prayer. It's a great prayer to pray - not just at the beginning of the year, but all throughout. Give it a shot. Try praying this prayer every Sunday in 2018 and see what happens!

I am no longer my own, but yours. Put me to what you will, rank me with whom you will; put me to doing, put me to suffering; let me be employed for you, or laid aside for you, exalted for you, or brought low for you; let me be full, let me be empty. let me have all things, let me have nothing: I freely and wholeheartedly yield all things to your pleasure and disposal. And now, glorious and blessed God, Father, Son and Holy Spirit, you are mine and I am yours. So be it. And the covenant now made on earth, let it be ratified in heaven. Amen.





frameworks that undergird the faith systems of non-Christian people here in America and around the world. SECOND CHURCH PREPARES TO MOVE AGAIN

Early in 1954 a nine-acre piece of property at 2829 Kingston Pike was put on the market for sale by the estate of Phil Briscoe, long-time member of Second Presbyterian Church and recently deceased. After several years of controversy in the church about whether to stay downtown on Walnut and Church and renovate or to move where there would be room to expand with adequate parking, the availability of this property seemed an ideal answer for the proponents for moving. Both Dr. Barbour and Dr. Copeland, his successor, were dealing with an aging building, bursting at the joints from overcrowded Sunday School rooms and an inflexible sanctuary and no public parking with very few options to allow for continued growth and programming. For almost a decade the issue was discussed by Session and congregation but no consensus could be reached—that is, until the Briscoe estate went on the market.

This property seemed to be exactly what a part of the leadership wanted—a highly visible metropolitan church site near the central city on a major highway, accessible by car from different directions with enough acreage for a large building with room for future expansion and adequate parking space. The property had an interesting history that we will briefly consider here. Beyond the site's 20th century usefulness as real estate, it had some historic links to Second Church's past.

History of The Land.

Originally the area around Knoxville was occupied about 1,000 years ago by a Woodland's people who

were gradually displaced by other groups until the end of the 1600s when the Cherokee nation moved in. White men began to move steadily into what is now East Tennessee and by the mid 1700s— through treaties first with the English and then the U. S.— Knoxville and surrounding properties were surveyed and sold. Several Scot-Irish original settlers named Armstrong bought and settled in Knox County. Second Church's historical link to 2829 Kingston Pike comes through part of the Armstrong family who were members of Second Presbyterian Church for several generations.

By 1850 Drury Paine Armstrong owned much Knox County property including 600 acres on both sides of Kingston Pike, beginning near what is now 2829 Kingston Pike and running westward near the restored historic house named Westwood. Three historic homes built by this Armstrong family still stand nearby, well restored and testimony to their proud past.

We owe words of gratitude to Morton Rose, member of Second Church for his research into the early history of Kingston Pike and Sequoyah Hills. Rose states:

The "Crescent Bend" house at 2728 Kingston Pike was built in 1834 by Drury P. Armstrong. Drury moved into the house in the same year with his wife, 3 children and 9 slaves. Drury was the son of Robert Armstrong III who was the famous surveyor of Indian and other lands. Today the "Crescent Bend" house is a museum and

features the Toms Memorial Silver Collection and a collection of Federal furniture...

"Bleak House" was built by R. H. Armstrong, son of Drury Armstrong, in 1858. Confederate General Long-street used this house as his headquarters during the attack on Fort Sanders. Some say that from the tower of this house, a sharpshooter shot General Sanders on the hill (where Second Church now stands). Today this house is known as the Confederate Memorial Hall.

"Westwood" was built in 1889 by John E. Lutz and his wife Adelia Armstrong Lutz, granddaughter of Drury Armstrong. The name "Westwood" comes from the fact that this was the first woods west of Knoxville. The name was an appropriate choice, for during the Civil War all of the area around Knoxville was denuded. [The house is presently occupied by Knox Heritage, a nonprofit which advocates for the preservation of structures and places with cultural or historic significance.]

History of The Road.

Kingston Pike was originally a Native American trail, which was only wide enough for horse travel, but was surveyed and opened in 1792 by Surveyor Charles McClung, son-in-law of James White, founder of Knoxville. McClung was commissioned to build a public road from Knoxville to Campbell's Station. The road was extended to Kingston by 1800.

During the Civil War, Kingston Pike played a vital role in allowing Union troops to move hurriedly from Campbell's Station Road to reach Knoxville's fortifications ahead of Confederate forces. General Sanders' dismounted cavalry troops delayed the Confederate army at the foot of now Second Church's hill to give Union forces thirty-six more hours to complete Knoxville's defenses.

According to *The French Broad-Holston Country*, in 1866 the Tennessee legislature chartered five private

turnpike companies in Knox County, one being the Kingston Turnpike Company authorized to build from Knoxville to Kingston and Sparta. Among the authorized commissioners were at least three members/elders of Second Presbyterian Church. One of these members, Oliver P. Temple, renowned lawyer and Union supporter during the Civil War became president of the company. Each company was allowed to erect toll gates every five miles from Knoxville and collect standard tolls. The Kingston Turnpike Company resurveyed the first five miles of the road and then macadamized it, raised the road, added ditches to facilitate drainage. Knox County purchased Kingston Turnpike in 1892 and completed the improved road to the county line in 1893. It was paved in the early 1920s and by the late 1940s widened to a four-lane road.

[One might conclude from this history of the land and the road that those earlier members of Second Presbyterian Church might have felt very much at home at 2829 Kingston Pike.]

The Planning Begins

The Phil Briscoe property was bought for \$60,000 with the estate contributing \$10,000 and on May 16, 1954, the congregation approved to build a new facility and move to Kingston Pike by a vote of 306-292. Under Presbyterian law this count was acceptable. The dissenters in the congregation and the moving advocates entered into a sad time of discourse involving threats of law suits and other actions. The bottom line saw the congregation splitting with part planning the move and the dissenters buying the Walnut Street Church building in 1957 and organizing themselves as a Congregational Church.

Ground was broken for the new church building on February 19, 1956, with Barber and McMurry as the architectural firm, headed by Ben McMurry and Dick Eckert as detail architect—both members of Second

Church. The church decided to demolish the Briscoe home, the extensive gardens and the foundation of a second house that Briscoe had planned to complete. The front grounds of the property were regraded and sloped gradually down to the sidewalk.

The church decided to move a few items from the Walnut Street Church and the selected items were:

It is not surprising that Second Church's leadership chose to keep the <u>tower bells</u> for the fourth building. The collection of ten bells at Walnut Street was considered to be perhaps the finest in the city and its peals had made themselves heard in both regularly scheduled weekly performances but also for special events. The **tower bells** were by far the largest and biggest challenge to move with their combined weight of over 11,000 pounds. With much difficulty the bells were removed from the Walnut Street bell tower and transported to the new site and stored until the construction of the new bell tower was completed. Later in 1998 three new memorial bells were added. More recently a memorial electronic computerized system was added to allow programming of many different pieces of music for the bells. These bells continue to be a vocal witness in the community, sounding out the Christian message of the Good News of Jesus Christ.




Baptismal fount from Walnut Street Church Sanctuary

The marble baptismal fount. Mr. and ✓ Mrs. John J. Craig III gave this fount to the church in memory of their daughter, Lucile Craig who died as a teenager. Mr. Craig owned and operated John J. Craig Company, a producer of pinkish Holston Formation limestone known as East Tennessee marble. His subsidiary company, the Candora Marble Company in South Knoxville, produced finished products from the quarried marble. Mr. Craig recruited Italy-born stone sculptor, Albert Milani, who became the company's chief carver for many years. It is likely that Mr. Milani, himself, carved the beautiful baptismal fount which now sits at the base of the chancel of the sanctuary. [This Holston Formation known as Tennessee marble was used in Washington, D.C. in the National Gallery of Art and for the stairways of the U. S. Capitol.]

One small <u>stained glass window</u> was saved and kept in storage until several years later when it was mounted in a door to the present library archives.

Various sections of <u>wooden framing</u> were saved and stored until they were used several years later where it was attached to the ceiling in the Fireside Room of the present library.

Historic wall plaques, one each representing Rev. Isaac Anderson, Horace Maynard, and Rev. Robert Bachman. These are wall mounted in the back hall leading to the sanctuary. In the narthex there is a plaque listing those individuals having served in World War I.

Two concrete door sills were taken from Walnut Street and were eventually placed on either side of the covered walkway that connects the Children's Center to the main church building. One represents the second building, dated 1860-1906, and the other the third building, 1906-1956.


